REGISTERING FOR STATES

<u>Registration Fee</u> for State Finals Tournament must remitted/postmarked by March 27, 2021 (\$25 by check or \$28 by PayPal, link is found on team's registration page once advanced). This fee is per team, per problem. If your team has advanced in more than one problem, it must submit the \$25 fee for each problem (an individual team may not compete in more than two problems). The registration fee must be paid prior to the tournament in order for your team to compete. Fee is \$100 if remitted/postmarked after March 27, 2021.

Team Submittals				
Is a team required to send pictures?	No, they are not required. It helps the Judges to Judge. Making it easier for the Judges is better for you.			
May a team send more than one video?	No, the team must combine your Teams' Solution & the Team's explanation into one submittal			
How many pictures can a team send?	Make it into one file. 10 pictures of your Long-Term items 4 Pictures of your Style 14 Pictures maximum			
Is the Script required?	No, it is not required. It helps the Judges to Judge. Making it easier for the Judges is better for you.			
What was the most common problem with the Outside Assistance Form?	Straight from the Form WE HAD HELP WTH: (Please describe any assistance with your specific problem solution if you had any. State NONE if no assistance was received. Also, please list names of former team members no longer on your team (if the roster exceeds seven) and when they last worked with the team. This portion was left blank. Please read the form carefully!			
What was the most common mistake in filling out the Style Form?	The most common mistake was the order that teams put their selections. Please list your Style selections per the rules of your problem. (These are not mere guidelines, they are rules)			
What is the other common mistake in filling out the Style Form?	What is a "LT Required Element" versus a "Style Element"? It cannot be chosen as a "Style Element" if it is a "LT Required Element". Same element cannot be scored in both Style and Long Term.			
What was the most common mistake in filling out the Cost Form?	Need to refer to the General Rules. Many teams are making costly mistakes. Pun intended! ③			
PRO Process (Virtual Staging Area)				
What is the PRO Process?	The PRO process is the Virtual Staging Area check in. This is where we check all your paperwork, make sure your video is watchable, and verify the number of pictures the team has provided.			
Team's Email – What could go wrong?	The PRO process uses the team's email to communicate problems that need to be fixed by the team. Some emails were schools and not available on the weekend. Causing delays.
